Agnieszka (PUT) presents the first draft of R1.3 "Report on education & training convergences and divergences and company good practices in IE&M" (it can be found [here](#)). She shows the most important elements, such as the key words to identify syllabi and the first draft results of the research, presented in the form of semantical map. All the partners are invited to provide feedback on this draft version of the report.

For collecting syllabi from other countries, PUT will send the Action Plan to the members of AIM. The members of that association will be informed by email by Mummolo (PoliBa), which is also the President of AIM.

PUT also talked with ESTIEM and provided them with the Action Plan. Agnieszka (PUT) underlines the importance of this task because the more data we have, the more detailed the R1.3 "Report on education & training convergences and divergences and company good practices in IE&M" will be. The deadline for both ESTIEM and AIM for providing PUT with the syllabi collected is 21.04.2020.

For what concerns the partnership, LIU will send to PUT the syllabi in the correct format to PUT in the next days.

Afterwards, the partner discuss about the next meeting scheduled for June in Poland. It will not be possible to be in Poznan because of the current COVID-19 emergency. The partners agree to replace the meeting in person with a virtual meeting that will take place on the dates of 24-25.06.2019. The partners agree to have a two-half day meeting: ValueDo will send a doodle for the meeting in June to decide the best time-slot for the meeting.

At that time the partners will decide whether to meet again in person in Poland from September on or to follow the initial schedule. The next meeting expected after Poznan is in November 2020, hosted by UPM in Madrid.

At this point, Mummolo (PoliBa) presents the questionnaire for HEI's (teachers, Program Coordinators, Dean) for Alumni and for Students. The complete documents are [here](#): these are the files that the partners are asked to analyse and to provide comments on. The deadline for the partners to comment the questionnaires is 17.04.2020.

After the common validation, the questionnaires will be transformed into online tools. PoliBa and PUT will work together to build up the online surveys.

Guadagni (Valuedo) suggests having another skype meeting at the end of April for discussing on the revised version of the questionnaires. At this purpose he will send a doodle for selecting the more suitable slots in the period between 27th and 30th of April.

- Associate Partners AIM and ESTIEM to provide PUT with the additional syllabi to analyse by **21.04.2020**.

- University Partners to test the new version of the survey with at least 5 students per University by **04.05.2020**.
